Please review the following guidelines for O2 use and respiratory equipment.

### **O2 Concentrators**

- As per routine practice, please call Careica (formerly RANA) at 1-855-672-6262 for installs and removals
- Each site should have ONE CONCENTRATOR per resident prescribed O2, and 1-3 spare concentrators depending on size of facility

# of beds	Spare Oxygen Concentrators
0-150	1
150-300	2
>300	3

- Please continue to properly clean and disinfect the concentrator using a <u>facility approved disinfectant</u> in between resident to resident use as per IP&C protocols
- o It is not advised at this time to have extra O2 concentrators on site more than what is listed in the above table.
- There will be no delay in getting the units to where they need to be, Careica has confirmed a delivery time for concentrators within 2-3 hours 24/7

NB: IT IS IMPERATIVE TO MAINTAIN OUR CONCENTRATOR POOL AVAILABILITY AT THIS TIME OF HIGH DEMAND, AS WE MAY NEED TO REALLOCATE TO AREAS OF HIGHER NEED.

## **02 Cylinders**

- Each site has O2 cylinders provided by Vital Aire for portability and for use in an emergency situation
- Please update your supplies to reflect the following:
  - An adequate amount of cylinders for the number of residents you have on O2 at your facility (i.e. enough tanks to facilitate 2-3 hours of portability for each resident on O2) \*refer to attached O2 cylinder timetable\*
  - ★ At least one O2 cylinder for emergency situations with regulator on and ready to for use
    - Please ensure cylinder and regulator are cleaned and disinfected prior to resident use and clean oxygen tubing is applied at time of use
  - Supply of O2 cylinder regulators & washers minimum of 1 per resident requiring O2 and for emergency tank(s)
  - Supply of nasal prongs adequate amount for number of residents on O2
    - Sites should be changing the O2 tubing based on facility policy and procedure
- It is not advised at this time to have extra oxygen cylinders on site
- Please ensure all O2 cylinders are properly stored as per fire regulations (see attached Medical Oxygen Storage Guideline)
- o If you need any of the above items, see attachment for equipment purchasing information
- WRHA PCH Respiratory Program can provide O2 tank carts if needed (we have approx. 10 available, on a first come first served basis)

#### CPAP/BIPAP

- Considered an aerosol generating medical procedure (AGMP) UPDATED

- If resident is COVID-19 positive, or suspected of being COVID-19 positive:
  - N95 mask is required when in resident room and CPAP/BIPAP machine is in use Airborne Precautions
  - A single room with door closed away from those who are immunocompromised is recommended during AGMP
  - → Minimize number of staff in room during AGMP and must use a N95 mask while in the resident room.
  - Staff may continue to enter/exit resident room during AGMP utilizing Airborne Precautions and ensure resident room door remains closed for the duration of AGMP
  - ◆ After turning off CPAP/BIPAP, door must remain closed for 3 hours; during this time, staff may continue to enter/exit resident room utilizing Airborne Precautions
  - ♦ When CPAP/BIPAP not in use, door may remain open Droplet/Contact Precautions

### **Nebulized Aerosol Treatments**

- Considered an aerosol generating medical procedure (AGMP) UPDATED

- NB: Conversion to a metered dose inhaler with a spacer device plus mask is recommended to help reduce the risk of transmission of infection <a href="https://sharedhealthmb.ca/files/covid-19-nebulization-ltc.pdf">https://sharedhealthmb.ca/files/covid-19-nebulization-ltc.pdf</a>
- If resident is COVID-19 positive, or suspected of being COVID-19 positive:
  - → N95 mask is required when in resident 's room and running aerosol treatment Airborne Precautions
  - → A single room with door closed away from those who are immunocompromised is recommended during AGMP
  - → Minimize number of staff in room during AGMP and must use a N95 mask while in the resident room.
  - Staff may continue to enter/exit resident room during AGMP utilizing Airborne Precautions and ensure resident room door remains closed for the duration of AGMP
  - After turning off nebulized aerosol treatment, door must remain closed for **3 hours**; during this time, staff may continue to enter/exit resident room utilizing **Airborne Precautions**
  - → When not receiving a nebulized aerosol treatment, door may remain open Droplet/Contact Precautions
