**RE: Seasonal Influenza Vaccine Supply Update**

Health Care Provider:

In order to meet ongoing demand for **seasonal influenza vaccine**, Manitoba Health will be providing Xanaflu® (Abbott Laboratories, Health Canada approved Inluvac® equivalent), in addition to FluMist®, Agriflu® and Fluviral®. Xanaflu® is administered intramuscularly and is indicated for use in adults 18 years of age and older. Xanaflu® protects against the same Influenza A and B strains as FluMist®, Agriflu® and Fluviral®. Xanaflu® is packaged with a Luer Lock syringe which is the same as what is currently on the Canadian market and is compatible with safety needles available in Canada. The most common is: BD Product # 305761 - 25G x 1" Eclipse (safety needle).

Health care providers should continue to use Manitoba Health's Vaccines and Biologics Order Form and indicate the total number of influenza vaccine doses requested. Manitoba Health will then verify all orders by phone to determine the flu vaccine product combination (Xanaflu®, FluMist®, Agriflu® and/or Fluviral®) based on availability. For the remainder of this influenza season, physicians should continue to bill for all seasonal influenza vaccines with tariff code 8791.
